



## Call for Papers and Pitches: Modern Land Administration for Development Forum – Arab States Autumn 2019, Amman - Jordan

We are pleased to announce the call for papers to the Modern Land Administration for Development Forum – Arab States that will be held in Amman, Jordan, Autumn 2019.

The Modern Land Administration for Development Forum is a high level forum organized by the Jordanian Department of Land and Survey (DLS) in partnership with the Netherlands' Cadastre, Land Registry and Mapping Agency (Kadaster). Within the context of attaining the UN 2030 Agenda for Sustainable Development, and as a follow-up of the 1st Arab Land Conference in Dubai in 2018, the Forum offers a platform for debate on the future of Land Administration in a sustainable and Fit For Purpose land administration system that suits the needs of society and environment as a whole.

The Land Administration for Development Forum is supported by the League of Arab States and the Arab Union of Surveyors, UN-Habitat, GIZ (German Agency for International Development) , World Bank , the Global Land Tool Network, and International Land Coalition (ILC).

Central to the Forum is the **Amman Declaration on Modern Land Administration for Development** which will be completed and signed during the 3-day forum by decision makers of the Arab states.

The event will have an open and interactive character; rather than presentations we ask participants to “pitch” their ideas or statements in 5 minutes and a moderator will facilitate the discussion that will follow. The set-up is a round-table rather than stage. Submission can include a maximum of 7 slides to back up your pitch. A paper is recommended to back up the pitch but the paper itself is not presented. The outcome of the discussion should feed into the Declaration and is structured around the below topics

The event sessions will be interactive and draw audience participations by initiating the sessions with short stories/presentations and then open discussion by the participants. If you are interested to present your story/idea on one of the topics listed below in Annex I, please submit a one page abstract outlining the content of your story/idea accompanied with no more than seven slides presentation to: Ms. Kholoud Saad [kholoud.saad@kadaster.nl](mailto:kholoud.saad@kadaster.nl)
