# Objectives

- **To present the concept note on the development of the global status report on land governance** to participants at the Global Land Forum for discussion and feedback.
- **To Reflect on the role key agencies could play** – as prospective contributors in the joint report.
- **To Reflect on the needs, requirements and support** for the development of this report with key recommendations on the way forward.

GLII proposes the development of a “Global Status Report on Land Governance” as a joint effort by the custodian agencies responsible for land related indicators in the SDGs.

Central to the successful development of this report is collaboration with and the support of agencies contributing quantitative and qualitative data and information. This includes UN agencies, the private sector, CSOs and the GDWGL among others working on related issues.

The Global Land Indicators Initiative (GLII) and IFAD will convene a session on ‘**Going Beyond Data to Developing a Global Status Report on Land Governance**’ for policy decision.

The session is informed by monitoring of land related indicators in the SDGs, with recognition of the efforts of the custodians and their supporting agencies (The World Bank, Food and Agriculture Organization, UN-Women, UN-Habitat, IFAD, UNCCD among others) in making data available to track progress on key targets. The discussion will also build on other related data sources and efforts by the private sector and CSOs working on data including PRIndex, ILC Land Dashboard, Land Mark etc.

SDG data is expected to serve as the core for the analysis and development of this report, which will be incremental in content, scope of analysis, and presentation of key issues on land governance. Building on GLII’s work and mission to achieve comprehensive land monitoring at scale by 2030, the Global Status Report on Land Governance will present a global

analytical piece on key issues in the land governance sector. These include tenure security, land administration, land and conflict, sustainable land use management, and will include cross-cutting issues like gender, among others which will be informed by available data and statistics on SDGs, and other authentic verifiable sources.

GLII and IFAD jointly host this session to consult the land and data communities which includes SDGs custodians, CSOs, the private sector, the Global Donor Working Group on Land (GDWGL) and the would-be users of this report on their feedback, expectations, and recommendations.

As data on SDGs and other initiatives becomes increasingly available, the global status report on land governance will be important for learning on key trends, progress and challenges, planning, and policy decisions by governments and various stakeholders..
