FURTHER INFORMATION

THE GLOBAL LAND TOOL NETWORK - GLTN is an alliance of 80 global, regional and national partners consisting of professionals, development partners, research and training institutions, technical and civil society groups contributing to poverty alleviation through land reform, improved management and security of tenure particularly through the development. Since its launch in 2006, it continues to develop and disseminate pro-poor and gender-sensitive land tools to address land tenure and reform issues.

Our partners work together to improve tenure security for as many people as possible by developing and disseminating: (A) An inclusive land tenure approach: one that recognizes various forms of tenure, and that involves stakeholders in seeking solutions that are fair and just to all, and (b) A set of practical, innovative land tools: practical, innovative methods to solve problems related to land tenure. We develop, test and demonstrate these tools in a range of countries, aiming to catalyse their wide use and adoption.

Our Network includes representation of all relevant professions and disciplines, civil society and grassroots organizations, multilateral and bilateral organizations. Because we are a network of organizations, many of which are themselves networks, we add considerably to our global footprint, country reach and on-the-ground impact.

GLTN Secretariat started preparing with colleagues and partners the Phase 4 Programme of the Global Land Tool Network. After concluding the Phase 3 by the end of 2023. The Phase 4 will be running for a period of 4 years (2024-2027) under the overall framework of the GLTN Strategy 2018-2030.

PREVIOUS GLTN PARTNERS' MEETINGS - The GLTN Partner's Meeting is held every two years to provide an opportunity for a Network wide engagement to review the work done, realign priorities and forge a way forward for partners' engagement in the delivery of the GLTN agenda. Since its formation, GLTN organized eight Partners' Meetings.
