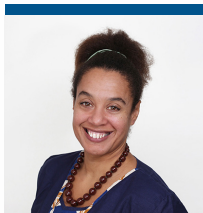

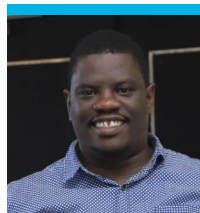
SIDE EVENT OBJECTIVES

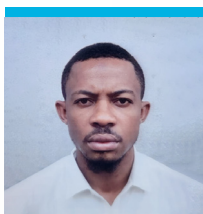

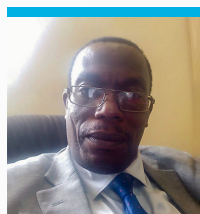
